 - Meets general accepted industry quality standards; and
 - Nationwide will replace any defective quality recycled part, reconditioned, remanufactured, OEM surplus, and any quality replacement parts as specified on the appraisal, for as long as you own or lease the vehicle.
- ◆ If you are a policyholder, a New York State Certification of Automobile Repair form.

I understand that the *On Your Side*® Appraisal Program is an optional damage appraisal service, and that I am not required or obligated to have my vehicle repaired at this shop or any other *On Your Side*® Appraisal Facility
